Terms: -

2. Can't refuse a child for admission just due to age proof of age. Can't refuse admission based on religion, clan, caste, birthplace or any one of its reasons.
3. The school will have to ensure that any child enrolled in the school is given primary education; the child cannot be stopped in one class or cannot be terminated from the school.

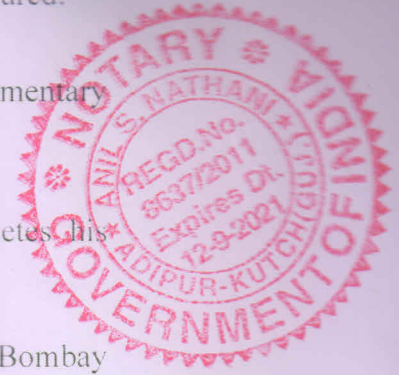

4. Do not physically punish any child or not to be mentally tortured.
5. No child can give any board exam till the completion of elementary education.
6. School has to issue certificate to each child who completes his primary education.
7. Provision for Mumbai Primary Education Act 1947 and Bombay Primary Education Rules, 1949, the teachers are to be appointed with the prescribed educational qualification as per the provision.
8. Prescribed curriculum by the competent education authority appointed by the State Government will only be taught in the school.
9. The school will have to provide admission to only those students as per the size of the classroom.
10. Invalid classes cannot be run within the school. And the same name cannot be run in another school.
11. School building, grounds or other infrastructure can be used only by developing education and skills. The group can run the same school as the Society Registration Act 1860 or any other law enacted.
12. School will not be able to run for profit.
13. Auditing of the school's annual accounts with the chartered accountant must be done and required statement must be certified and one copy of it must be sent to the competent attorney.
