Important Notes: 1. The total number of section of the school shall be restricted to 15 (as per prescribed dimension) as per the number of class rooms reported during inspection and further increase shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation by elaws.

- 2. Provision for CWSN is not covered in the video. Thus, the school is directed to construct a ramp at the entrance of the school and a ramp or lift to access upper floors and separate toilet for girls and boys CWSN students on every floor with proper infrastructural facilities in accordance with the provisions laid down in RPWD Act-2016 within 3 months and submit the compliance on SARAS portal.
- 3. The school is to increase the resources in Music room as suggested by IC. The school needs to develop proper outdoor sports facilities.
- 4. The school is to increase Books in Library and to keep all the CBSE manuals in the library as suggested by IC.
- 5. The school is required to increase sports facility and resources along with number of Physical Education Teachers as suggested by IC. The school shall follow the SoPs issued by the Board in respect of labs, library and sports facilities and submit compliance within 3 months on SARAS portal.
- 6. The school shall conduct training of its teachers with CoE Pune within 3 months and submit the compliance on SARAS portal.
- 7. The school shall get all the mandatory certificates renewed periodically.
- 8. The school is directed to maintain a distinct mandatory public disclosure link in its website as mentioned in circular No.9/2021 dated 21/05/2021 and upload all essential documents and do not remove the documents and the videography link of the inspection /infrastructure from YouTube from its website.
