With regard to the above matter, Principal, Podar International school, Kunigal Road, Tumakur has requested to issue school building safety certificate as per above reference 3.


Accordingly, school building inspection was conducted at the premises of M/S Podar International school, Kunigal Road, Tumakur, on 17-01-2026 alongwith Principal.

The school features a G+2 structure with R.C.C roof. There are 14 rooms including 3 office rooms, separate rest room facilities for boys and girls.

This school is located on the left side of the Koratagere – Bhavali road (State Highway SH-33) at 33.2 KM. The school building is constructed using cement blocks, RCC columns and has an RCC roof.

Also, TEKNA-KON Chartered engineers, Architects & valuers, Bangalore has provided the school building stability report based on which school has been certified as, "The Building is stable (Concrete structure such as RCC Columns, Rood & Beams) as per Volume – 1 of National Building code of India - 2016.

As indicated in above reference (1) circular issued by Government under serial number (2), Schools in rural areas have to deposit fees of Rs.1,000 (Rupees One Thousand only), the above said school has paid the fees of Rs.1000/- through DD number 013203 dated 16-01-2026 drawn from IDBI Bank. The same has been mentioned above in Reference no.4.

If there are any changes or alterations made to the above mentioned school building, the issued certificate stands to be automatically cancelled. The said certificate issued to Podar International school, Kunigal Road, Tumakur is to be used for school building and education purposes only. Based on reports and subject to terms of suggestions given by TEKNA-KON chartered Engineers, Architects & Valuers, Bangalore, as per the reference (2) mentioned above, the school has been issued School building safety certificate for a period of two years from 20-01-2026 to 19-01-2026.
